## WEST FLORIDA PHRF BOAT OF THE YEAR SERIES Regatta Organizers Agreement

As established in Appendix H, of the WFPHRF Class Rules:

"In order to encourage participation in Performance Handicap Racing, WFPHRF endorses several regional "Boat of the Year" (BOTY) series. The Race Organizers of these events are solely responsible for the management of the individual events."

To maintain a level of consistency among the events used in scoring for a WFPHRF BOTY Series, WFPHRF asks the Race Organizers to include the WFPHRF Class Rules as part of the rules that govern the event in their Notice of Race (NOR), with an exception for any non-PHRF, one-design fleets participating in the event.

Additionally, WFPHRF recommends the following in an effort to make WFPHRF BOTY events as successful, enjoyable and consistent as possible:

• In your Notice of Race, initially include entrants from all WFPHRF racing fleets in any WFPHRF endorsed Charlotte Harbor, Southwest Florida, Sarasota Bay, Gulf and Suncoast Boat regions of the BOTY Series.

• Provide a draft of your Notice of Race and entry form prior to publication to WFPHRF for review. WFPHRF will respond with any questions within 5 working days of receipt of the draft. In an attempt to provide our fleets with easily accessible regatta information, WFPHRF will publish a link to each region's Notice of <u>Series</u> on the <u>www.westfloridaphrf.org</u> web site which will include a list of BOTY regattas as listed by the series organizers.

Have a US Sailing Certified Race Officer as the Principal Race Officer (PRO) or supervisor of your PRO(s). If you need
assistance in finding a US Sailing PRO, WFPHRF may be able to help you find one.

 Have at least one US Sailing Certified Judge as part of your Protest Committee. Again, WFPHRF may be able to assist you in finding a US Sailing Certified Judge.

• Submit detailed scores of all event races using Time-On-Distance (TOD) or Time-On-Time (TOT) calculations for all monohull classes and TOT for all multihull classes. If other than TOD is used to score monohulls or TOT is used to score multihulls in your event at the local level, WFPHRF asks that you submit raw data (distance of each race and finish time for each yacht) to the WFPHRF Board of Directors for inclusion in Boat of the Year Series scoring by 2100 hours on the Wednesday following your event. WFPHRF will endeavor to post the scores as provided by the Race Organizers on the web site, <u>www.westfloridaphrf.org</u>. The results will be posted as preliminary if there are any protests pending and the date of the protest hearing will be noted on the Boat of the Year Series Scoring section of the WFPHRF web site.

The organizer agrees to abide with these recommendations for this event to be scored in a WFPHRF endorsed Charlotte Harbor, Sarasota Bay, Southwest Florida, Gulf or Suncoast PHRF Boat of the Year Series.
